GUEST SPEAKER



Colonel Cuccio, a Mahopac, New York native, was commissioned on May 31, 1989 upon graduation from the United States Naval Academy. Following completion of The Basic School and Infantry Officer Course,

he reported to the 1st Marine Division in Camp Pendleton, California where he served as a Rifle Platoon Commander, Company Executive Officer, and Combined Anti-Armor Platoon Commander with 3d Battalion, 1st Marines. While with 3/1, he deployed to the Persian Gulf with 5th Marine Expeditionary Brigade for Operations DESERT SHIELD and DESERT STORM, participated in riot control during the 1992 Los Angeles riots, and completed a deployment to Okinawa where his battalion was the ground combat element of 31st Marine Expeditionary Unit.

In 1993, Colonel Cuccio reported to Marine Barracks, Washington DC where he served as a Platoon Commander, Company Executive Officer, and as OIC of the Warfighting Skills Program at the Marine Corps Institute. After attending Amphibious Warfare School, Colonel Cuccio reported to 2d Marine Division in Camp Lejeune, North Carolina and served as Commanding Officer of Headquarters Company, 2d Marine Regiment; Commanding Officer of Charlie Company, 1st Battalion, 2d Marines; Commanding Officer of II MEF Marine Forces Unitas; and as Assistant G-3 Operations Officer, 2d Marine Division. From April to October 1999, he served as an individual augment at Headquarters, United States European Command in Stuttgart, Germany as a Contingency Operations Planner in support of Operations ALLIED FORCE and JOINT GUARDIAN. During this period, he was forward deployed to Pristina, Kosovo to serve as a Liaison Officer to Headquarters, Kosovo Force. While with Unitas, he completed a 5-month shipboard deployment to South America.

From 2001 to 2004, Colonel Cuccio served as Assistant Head, Enlisted Retention and Counseling Section (MMEA-6), M&RA, Headquarters U.S. Marine Corps. In 2004, he was reassigned to the

Joint Staff, where he served as Assistant Chief, Multinational Operations Division, Operations Directorate (J-3). In 2007, Colonel Cuccio reported to 3d Marine Division in Okinawa, Japan and served as the G-3 Future Operations/Plans Officer until May 2010. In 2008, he was deployed to Afghanistan in support of Operation ENDURING FREEDOM as an Embedded Training Team Officer-in-Charge with the 201st Corps of the Afghan National Army.

Colonel Cuccio was promoted to his present rank in October 2010. From Oct 2010 to Jun 2013, he served as Head, Expeditionary Policies Branch (POE), PP&O, Headquarters U.S. Marine Corps. His current assignment is Chief of Staff, U.S. Marine Corps Forces, South.

Colonel Cuccio has a Bachelor of Science degree in Ocean Engineering from the United States Naval Academy and a Master of Arts degree in International Affairs from the Catholic University of America. He is a graduate of the Air War College nonresident program, Senior Planner Course, Joint and Combined Warfighting School, Marine Corps Command and Staff College nonresident program and Amphibious Warfare School.

His personal decorations include the Legion of Merit, Bronze Star with Combat Distinguishing Device, Defense Meritorious Service Medal, Meritorious Service Medal with two Gold Stars, Joint Service Commendation Medal, Navy-Marine Corps Commendation Medal with Combat Distinguishing Device and one Gold Star, Navy-Marine Corps Achievement Medal, Army Achievement Medal, and Combat Action Ribbon with one Gold Star.

Marine Corps Forces South's focus is on the Latin American Marines, Naval Infantry, and Maritime Security Forces; anti-terrorism; and peacekeeping, humanitarian assistance and disaster relief. They build security forces to detect, deter, and defend critical infrastructure and assets. They help establish SOUTHCOM's maritime domain awareness as well as build partner nation capabilities for UN peacekeeping missions in Haiti, Congo, and the Middle East.

TOYS FOR TOTS

Please note that we are asking all members that are attending the December 17th dinner social to bring a new toy (or two) for Toys for Tots. Your kindness will put a smile on a young child's face this holiday season. Below is the history of Toys for Tots.

Toys for Tots began as a Los Angeles charitable effort in 1947. Major Bill Hendricks, USMCR, was inspired by his wife Diane when she tried to donate a homemade Raggedy Ann doll to a needy child but could find no organization to do so. At her suggestion, he gathered a group of local Marine reservists, including Lieutenant Colonel John Hampton, who coordinated and collected some 5,000 toys for local children that year from collection bins placed outside of Warner Bros. movie theaters. Their efforts were so successful that, in 1948, Toys for Tots was launched as a national campaign. Hendricks used his position as director of Public Relations for Warner Brothers Studio to enlist celebrity support, as well as have Walt Disney Studios design the red toy train logo.

Until 1979, Marine reservists (frequently in their dress blue uniforms) and volunteers would collect and refurbish used toys. In 1980, only new toys were accepted, as reservists were no longer able to dedicate drill hours to refurbish toys, as well as legal concerns and the mixed message of giving hand-me-downs as a message of hope. In 1991, the Secretary of Defense authorized the creation and affiliation with the non-profit charity foundation. In 1995, the Secretary of Defense approved Toys for Tots as an official mission of the Marine Corps Reserve.

As of 2013, the Toys for Tots Program and Foundation have collected and distributed more than 469 million toys.

REMEMBERING TWO GREAT MEN




Just last month, an article appeared in The Helmsman on Honor Flight. Allan F. McElhiney, Jr., founding father of the Naval Air Station Florida Museum, was one of the WWII veterans who was able to experience the trip to Washington DC. Allan passed away on November 9, 2014, his 89th birthday. He was an amazing man and his story is below.

Allan McElhiney was born November 9, 1925 in Lynn, Massachusetts. His father was a Marine who served in World War I. Allan has three brothers, all of whom served in the military, and one sister. On Allan's 17th birthday, his parents signed his papers to join the Navy. Beginning in 1944 he served on a Patrol Frigate, the USS Asheville (PF-1) based at Port Everglades on convoy duty. After WWII while in the reserves, he was called to active duty for the Korean Conflict, back aboard the USS Asheville. After his discharge from the Navy, like many veterans who had spent time or heard stories of our area, Allan moved with his wife Carolyn and five children to Fort Lauderdale, where he started a wall-covering business. In the 1970's, he joined the Navy League and later became chairman of the Sea Cadet Program.

In 1979, Allan along with Ben Langley MCB7, Army Col. Robert Rawls, Chief Stephen Sedillo USCG, and a handful of history enthusiasts and supporters, established the Naval Air Station Fort Lauderdale Historical Association. Their main mission was to save from demolition at least one of the buildings from the large naval base. They were successful in preserving Building #8 "The Link Trainer Building," after having it placed on the National Register of Historic Places on May 20th 1998. In December 1999, after much work and preparation the building was moved to its permanent location at 4000 W. Perimeter Road. Restoration has continued since, to complete his dream of a permanent place (Naval Air Station Fort Lauderdale Museum) to honor the service and sacrifices of those who trained here during WWII. In the course of more than 30 years McElhiney compiled a vast amount of documents, photographs, articles and artifacts that are on display at the Museum.

Beginning on December 5, 1989 Allan has presided over the Flight 19 Memorial Ceremony, originally at Navy Park and more recently in the Museum building. This annual ceremony is open to the public.

Over the past several years, Allan's physical health has deteriorated, limiting his activities; however his keen mind and sharp wit remained. Having learned of the Honor Flight, he was invigorated by the opportunity to travel with other World War II veterans to visit the WWII, Korea, Iwo Jima Memorials, and Arlington Cemetery in Washington, DC. It was obvious to his family and friends how very important this was to him. With the great help of Honor Flight South Florida volunteers, he made the trip on October 11th, 2014. His joy was palpable, especially with the reception celebration on their return that night to Fort Lauderdale-Hollywood International Airport. On November 9, 2014, after a long battle with Parkinson's disease, Allan passed away on his 89th birthday.



Long time Navy Leaguer Dolph Du Mont passed away on November 16, 2014. Dolph was a member of the Fort Lauderdale Council and previously served as their Council President. Recently Dolph served as a Navy League National Director. Dolph was also a strong supporter of the Spruance Division Naval Sea Cadets.

Dolph served as a Navy diver in WWII participating in the cleanup of Pearl Harbor. He had served as chairman of Manadu Corporation, an international management consulting firm, and remained active in the firm. Dolph was very active in a variety of fundraising events and civic pursuits and recently served on the Broward Sheriff's Advisory Council as a director and treasurer. His wife, Pat Du Mont, is also a long time Navy Leaguer and a member of the Fort Lauderdale Council. Dolph and Pat were married for over 40 years.






SHOEBOX CHRISTMAS

INDIVIDUAL AUGMENTEE RECOGNITION LUNCHEON


On November 16, Naval Operational Support Center (NOSC) Miami sailors mobilized for Operation Iraqi Freedom, Operation Enduring Freedom, Global Contingencies and other critical areas beyond our borders were honored. NOSC Miami is one of the Council's adopted units. The event was held at Shula's Hotel in Miami Lakes and was co-sponsored by the Broward County, Fort Lauderdale and Miami Navy League Councils. Broward Navy Days and the Everglades Council Navy League also supported the event. Those sailors being honored were Individual Augmentees (IAs) - sailors who have left their assigned units or commands to deploy individually or in small groups. They are usually assigned to units to fill specialized roles that military units either have difficulty filling or those that require special expertise. Little or no ceremony marks their deployment or return. Often, with little notice, IAs are asked to head to unknown territories, face unknown enemies and spend over a year away from their homes and families.

Chuck Black, Navy League South Florida Area President, made the opening remarks and the Spruance Division Sea Cadets presented the colors. Remarks were made by CDR Harold W. Long, Commanding Officer of NOSC Miami. The guest speaker was RDML Scott B. Jerabek USN, Director of Theater Engagement (D7), U S Southern Command. The presentation of awards was made by CDR Long, LCDR Jason Michewicz (XO NOSC Miami), RDML Jerabek and Navy League Council representatives.

SEA SERVICE NEWS



Captain Derek Herrera, a Marine who was left paralyzed by a sniper's bullet in Afghanistan fulfilled a promise to himself on November 21 and walked using robotic leg braces in a ceremony at Camp Pendleton, where he was awarded a Bronze Star.

His commanding officer, Lt Col. John J. Lynch, commanding officer of the Marine Corps Special Operations Command, presented him the award. Herrera had vowed to walk at the event that also marked his retirement after 8½ years in the military, saying he wanted to leave the Marine Corps the same way he joined. The special operations officer was honored with the Bronze Star for his actions on June 14, 2012, when the patrol he was leading came under heavy fire in Afghanistan. Herrera continued coordinating efforts while receiving treatment for his own spinal injury and collapsed left lung. Left paralyzed from the chest down, the 30-year-old Marine sought to be allowed to remain on active duty and pushed himself to get back to walking. His last day on active-duty is November 30. Herrera was the first person in the United States to purchase the ReWalk system, a robotic exoskeleton system that allows people with spinal cord injuries to stand and walk. The MARSOC Foundation, a charitable fund for members of the Marine Corps Special Operations Command, raised the money for Herrera to buy the \$69,500 device. Herrera is working on a master's degree in business administration at the University of California, Los Angeles and plans to start his own business.

Office of National Drug Control Policy Deputy Director for Supply Reduction Marilyn Quagliotti presented the United States Interdiction Coordinator (USIC)

Award to Operation Bahamas Turks and Caicos (OPBAT) on November 17. "Operation Bahamas Turks and Caicos is an outstanding example of a partnership which employs existing capabilities to meet a wide range of demands," said Deputy Director Quagliotti, who serves as the U. S. Interdiction Coordinator (USIC). OBAT is a multi-agency, international drug interdiction effort focused primarily on stemming the flow of illicit drugs from South America and the Caribbean to the Bahamas, the Turks and Caicos Islands, and the United States. In 2013, OPBAT prosecuted 428 separate law enforcement cases, seized \$32,057,774 worth of marijuana, and interdicted more cocaine than in the past three years combined. Additionally, OPBAT arrested 154 narco-traffickers during law enforcement operations in 2013, and continues to deter drug trafficking groups from using the Bahamas and Turks and Caicos for cocaine transportation.



The "Grim Reapers" of Strike Fighter Squadron (VFA) 101, the Navy's first F-35C Lightning II carrier variant squadron, reached a milestone in November 2014

by surpassing 1,000 mishap-free flight hours in the F-35C. As the F-35C Fleet Replacement Squadron, VFA-101, homeported at Eglin Air Force Base, Florida, trains Navy aircrew and maintenance personnel to fly and repair the aircraft. The unit became the Navy's first F-35C squadron after receiving the aircraft June 22, 2013, from Lockheed Martin, and completed the first check flight, August 14.
